



STATE-OF-THE-ART FACILITY.

HydroChemPSC owns and operates a state-of-the-art crude oil reclamation and non-hazardous oilfield waste facility located two and one-half miles east of Jeanerette, LA on State Highway 87. The 59,000 barrel capacity facility features an injection well, Coast Guard approved docking and transfer operation, and a truck receiving station that can accommodate six vacuum trucks simultaneously.

FULLY PERMITTED.

The HydroChemPSC Jeanerette location is the only Louisiana facility permitted to accept crude oil for reclamation and permitted to inject waste water generated from the drilling and production of oil and gas. This operating permit is issued by the State of Louisiana, Department of Natural Resources and Office of Conservation.

CRUDE OIL RECLAMATION.

Purchasing salvageable crude oil from the generator allows them to receive a salvage value for what would otherwise be a costly disposal expense. HydroChemPSC will provide on-site sampling of waste streams to determine the percentage of reclaimable oil versus the percentages of BS&W.

HydroChemPSC also purchases gas plant waste (drip or condensate) and pipeline crude oil that may be unacceptable for pipeline marketing. These waste streams are useful to us for in-plant blending in the reclamation process. The Office of Conservation recognized the need for blending stocks and has classified HydroChemPSC as a reclaimant of those marketable products.

FLUIDS INJECTION

HydroChemPSC offers the oil and gas operators flexibility to dispose of their E&P waste streams in an environmentally sound and highly regulated process through deep well injection. With oversight from the State of Louisiana, Department of Natural Resources, HydroChemPSC continuously monitors the well operations to ensure our clients' waste streams are disposed of in the safest and most efficient method available.
